**Location:** Downers Grove North High School Pool, 4436 Main St., Downers Grove, IL 60515. Please enter pool off of Prince Street (one block west of Main St.)

**Facility:** Eight lanes, 25 yards, non-turbulent lane lines with a starting depth of 8 1/2 feet to 4 feet at the turn end. A separate diving well will be available for warm-up and cool-down. Fully automatic *Colorado V* timing system, button back-up and an 8-lane scoreboard. Permanent starting blocks are slanted 15 degrees and conform to USA Swim standards. Balcony seating for spectators.

**Eligibility:** Only USA Swimming registered swimmers representing the Chicagoland Conference Bronze Division teams are eligible to participate. All swimmers must be registered prior to entry deadline\ A swimmer's age as of February 23, 2003 will determine their age for the meet.

**Entries:** All entries must comply with current USA Swimming and ISI Rules and Regulations. Current registration number, age, first name, middle initial, and last name must appear on all entry forms. Entries must be submitted on a Hy-Tek Commlink disc (3 1/2") or via e-mail using a Hy-Tek Commlink file in zipped format as an attachment. E-mail entries are acceptable. Please follow-up with a hard copy of the entry and a disk as soon as possible. Facsimile entries will not be accepted.

**Entries must be received by the meet entry chairperson no later than 5:00 PM on Monday, 14 February 2005. E-mail is the preferred method of entry.**

- Events:** All events will be timed finals and will be seeded immediately following the scratch deadline. All heats will be swum slowest to fastest in the order included. **FINA starting procedures and rules (whistle commands and no recall) will be in effect for this meet.**
- Entry Fees:** An entry/award fee of \$400.00 is due to All-Start Awards by the entry deadline.
- Entry Limitations:** Each swimmer may participate in a total of three individual events and two relay events. Each team may enter a maximum of three (3) swimmers in each individual event and one relay team. Deck entries will not be permitted.
- Awards:** Awards will be given to the top twelve (12) finishers in each non-senior event.
- Deck Access & Credentials** Only contestants, coaches and working meet officials will be granted access to the competitive area. Current USA Swimming membership card must be continuously displayed while on deck. Coach's information packets will be available at the meet. Please advise your team that only authorized individuals will be allowed access to the deck.
- Meet Workers:** Each team will need to supply :  
1 Official  
2 Timers
- Admissions:** \$3.00 for adults; \$2.00 for non-swimmers/students . Psych sheets will be sold for \$3.00.
- Concessions:** Concessions will be available throughout the meet in the Purple Gym Lobby.
- Results:** One copy of the results will be mailed to each team. Final results will be available to all others at the admissions table for a fee of \$5.00.
